

Refund Policy

RichOffSous and K

ALL SALES ARE FINAL. NO REFUNDS.

This Refund Policy is part of our Terms of Service. By purchasing any product, plan, or membership from RichOffSous and K on Whop, you acknowledge and agree to this policy.

1. No Refunds

We do not offer refunds, returns, credits, or exchanges for any reason. This includes, without limitation:

- One-time purchases and recurring subscriptions
- Unused time remaining on a billing period
- Dissatisfaction with picks, results, win rate, or unit performance
- Losing wagers or failing to profit
- Not using the community, chat, or content after purchase
- Changing your mind, accidental purchase, or duplicate purchase
- Loss of access due to violation of our Terms of Service
- Device, internet, or third-party platform issues on your side

Our Service is digital entertainment (sports picks, discussion, recaps, and community access). Access is delivered immediately after purchase. Because of that, all sales are final at the moment of checkout.

2. Why Sales Are Final

Picks and related content are time-sensitive entertainment. Once you have access, the value has been delivered and cannot be returned. A cooling-off or trial refund would let someone view picks and then demand their money back. That is not permitted.

3. Subscriptions

If you have a recurring plan, you may cancel at any time in your Whop account to stop future renewals. Cancellation takes effect at the end of the current paid period (you keep access until then) and **does not** refund any amount already charged for the current or prior periods. It is your responsibility to cancel before the renewal date if you do not want to be charged again.

4. Chargebacks and Payment Disputes

Filing a chargeback, dispute, or claim with your bank, card issuer, or payment provider instead of contacting us is a breach of these terms. If you initiate a chargeback:

- Your membership and access may be terminated immediately, without refund of any remaining time.
- We will submit this Refund Policy, our Terms of Service, your checkout acceptance, and access/usage records as evidence.
- You remain responsible for the original charge and any fees we incur defending the dispute if the chargeback is reversed or denied.

If you have a billing question, message us through Whop first.

5. Entertainment Disclaimer

All content is for entertainment only. We do not promise wins, profits, or accuracy. Results, good or bad, are not grounds for a refund.

6. Required-by-Law Exceptions

If a law that applies to you requires a refund or cancellation right that this policy cannot waive, we will honor that legal requirement and nothing else. Where a mandatory right exists, you must request it through Whop messaging and provide the information reasonably needed to process it.

7. How to Cancel

To stop future charges: open your Whop account, go to your membership for RichOffSous and K, and cancel. Canceling is not a refund request and will not produce a refund.
