

Terms of Service

RichOffSous and K

Effective date: September 1, 2026

These Terms of Service govern your access to and use of the RichOffSous and K community, products, content, and related services offered on Whop. By purchasing, joining, or using the Service, you agree to these Terms and to our Refund Policy. If you do not agree, do not buy or use the Service.

1. The Service

RichOffSous and K provides sports-related content for entertainment, including daily sports picks, table tennis split-method plays, MLB, NFL, NBA, and WNBA plays, suggested unit sizes, pick discussions, community chat, results and recaps, and related community access. Content, format, volume, and schedule may change at any time.

2. Entertainment Only. Not Advice.

All picks, analysis, unit suggestions, recaps, chat discussion, and other content are provided **solely for entertainment and informational purposes**.

- Nothing we publish is sports betting advice, gambling advice, financial advice, or a recommendation to wager money.
- We do not guarantee wins, profits, accuracy, or any particular result. Sports outcomes are uncertain. Past results do not predict future results.
- You are solely responsible for any decisions you make, including whether to wager, how much to wager, and whether you are legally allowed to do so where you live.
- If you choose to gamble, do so only where it is legal for you, only with money you can afford to lose, and never as a way to make income.

3. Eligibility

You must be at least 18 years old (or the age of majority in your jurisdiction, whichever is older) to purchase or use the Service. By using the Service, you represent that you meet this requirement.

4. Membership, Access, and Billing

- Access is delivered digitally through Whop (chat, content, and any other experiences included in your plan).
- Fees, billing interval, and what is included are shown at checkout. Recurring plans renew automatically until you cancel.
- You are responsible for keeping your Whop account secure and for activity under that account.
- Access is personal and non-transferable unless we expressly allow a transfer.

5. Refunds

All sales are final. We do not offer refunds. See our Refund Policy for the full terms. Canceling a subscription stops future renewals; it does not refund time already paid.

6. Acceptable Use

You agree not to:

- Share, screenshot for resale, leak, resell, or redistribute picks, recaps, or other paid content outside the Service.
- Share your login or membership with others.
- Harass members or staff, spam, or disrupt the community.
- Use the Service for any unlawful purpose, including unlawful gambling.
- Scrape, copy, or commercially exploit our content without written permission.
- Misrepresent our content as guaranteed, as advice, or as your own.

We may suspend or terminate access immediately for violations, without refund.

7. Intellectual Property

All picks, write-ups, recaps, branding, and other content in the Service are owned by RichOffSous and K or its licensors. Purchase gives you a limited, personal, revocable license to view the content for your own entertainment while your membership is active. No other license is granted.

These Terms are governed by the laws of the State of New York, without regard to conflict-of-law rules, except where the laws of your place of residence require otherwise.
